



# 11<sup>th</sup> IGA Women's Match Play Championship

conducted by the Iowa Golf Association

Talons Golf, Ankeny

Tuesday-Friday, June 28-July 1, 2022

**ELIGIBILITY:** Applicants must be an active IGA Member. Individual members are tracked through their enrollment at an IGA Member Club (via GHIN). Eligible entries must be female amateur golfers as defined by the USGA rules. Members of the IGA (thru an IGA Member Club) from out-of-state are eligible to compete. **She must have an up-to-date women's Handicap Index not exceeding 20.0 under the USGA Handicap System.**

**FIELD:** The field will be limited to the first 144 combined (between Men's & Women's Match Play) eligible entrants. There will be 32 guaranteed spots for the women.

**EXEMPTIONS:** The defending champion (Leanne Smith) is exempt from the 18-hole qualifying round. The defending champion may choose to compete in the qualifying round to earn medalist honors but is assured of no lower than the #2 seed in Match Play.

**FORMAT:** Depending on the total number of entrants in the Women's Match Play, the IGA will establish a bracket of either 8, 16, or 32. 18-hole stroke play qualifying on Tuesday will determine the seeds for match play. In the event that more than 32 women enter, the stroke play qualifying round will determine the low 32 that move onto match play with a hole-by-hole playoff breaking any tie for the final qualifying spot.

Assuming a bracket of 32 the format will be as follows:

Tuesday, June 28 - 18 Holes Qualifying Round

Wednesday, June 29 - Morning Round of 32

Wednesday, June 29 - Afternoon Round of 16

Thursday, June 30 - Morning Quarterfinals

Thursday, June 30 - Afternoon Semifinals

Friday, July 1 - Morning Finals

\*The IGA reserves the right to alter this schedule depending on the number of entrants and the size of bracket for the Women's Division.

**MEN'S MATCH PLAY:** The IGA will be hosting the Men's Match Play Championship concurrently with the Women's Match Play Championship. There is a separate entry application for the Men's Match Play Championship (available at [www.iowagolf.org](http://www.iowagolf.org)). The combined field for the men's and women's championships will be 156 players, with at least 32 guaranteed for the ladies.

**PAIRINGS, TEE TIMES:** Entry confirmation & pairings will be emailed from the IGA office after the entry deadline. Pairing information will NOT be sent via standard mail to those who do not provide an email address. Pairings will also be made available on the IGA website, [www.iowagolf.org](http://www.iowagolf.org). Field will be paired at random for the qualifying round.

**PRACTICE PRIVILEGES:** Practice rounds will not be allowed for this event.

**WITHDRAWALS AND REFUNDS:** Entry fees will be refunded if the IGA office is notified on or before June 14. After June 14, fees will be refunded only in event of injury or illness. There will be a \$20.00 service charge on all refunds.

**ENTRY FORM, FEE, and CLOSING DATE:** Entrants are solely responsible for securing and returning entry forms and fees by the due date. Entries must reach the IGA office by 3:00 P.M., June 20 and must be accompanied by the appropriate fee (\$90). You may enter online using a credit card at [www.iowagolf.org](http://www.iowagolf.org) up to the deadline or until a field limit is met, whichever comes first. Late, unsigned or incomplete applications are not acceptable and will be returned. There will be no exceptions!

**WAITLIST:** If a player exceeds the Handicap Index Limit of 20.0, she is eligible to be added to a waitlist by contacting the IGA. If the field does not fill, players will be added to the field from the waitlist. The waitlist will be ordered from lowest to highest Handicap Index.

**CONDITIONS, SCHEDULES:** Once the match play bracket has been announced or published any player(s) that withdraws from the competition results in a forfeit of their match (bracket remains as published). The IGA reserves the right to alter any of the conditions and schedules herein as needed. This may include, but is not limited to, suspending play to a following day, or canceling current or future rounds. The decision of the Rules and Competitions Committee in any matter shall be final. Under any circumstances, all possible attempts will be made to complete the event in the scheduled number of rounds.

#### GOLF BALLS; DRIVER HEADS

Only brands of golf balls on the most current USGA List of Conforming Golf Balls and driver heads on the most current USGA List of Conforming Driver Heads may be used. Updated lists may be found on the USGA website at [www.usga.org](http://www.usga.org) or by contacting the USGA Equipment Standards Department at (908) 234-2300.

**PERSONAL APPEARANCE:** Proper golf attire is mandatory; the committee reserves the right to determine whether this requirement is met. Competitors may be required to change clothing in order to compete. Traditional ladies' golf attire will be permitted. Blue jeans are NOT permitted.

**PACE OF PLAY:** In accordance with Rule 5.6b(3) the IGA has adopted pace of play guidelines that include the maximum period of time allotted to complete a stipulated round, number of holes and/or strokes. These guidelines and the resulting penalties will be made available to every competitor in advance of the championship.

**RULES OF GOLF:** Play will be governed by the Rules of Golf. Local rules on scorecards do not apply. Decisions concerning the rules will be settled by the Rules Committee assigned by the IGA and those decisions will be final.

**It is the policy of the Iowa Golf Association that, in a match play event, at least eight (8) individuals must enter an event to constitute holding such event. If seven (7) or less enter a championship it will be canceled. Entrants to such event will be given the option to participate in another championship where eligible, or receive a full refund on entry fees as soon as practical.**
